



Medina Swarm December 3 & 4 CPE Agility Trial

The building will be open at 6:30 a.m. for set up. **Measuring will be done at 7:30.** First dog on the line at 8:00 a.m. both Saturday and Sunday. Our judge will be June Ritchhart.

There will be DAY OF SHOW entries (until we reach our maximum of 375 runs per day) at \$18 per class from 7:00 – 7:30 each day. Please bring a completed Premium. We would appreciate a check or correct change. If you know of someone coming for DOS, please advise them.

Final move up is November 28th at 6:00 pm EST. **There is a \$5.00 fee per class for ANY changes after November 28.** Standard, Jumpers, & Snooker move ups from Saturday to Sunday must be made on Saturday before leaving the trial site.

The running order will be posted by Thursday, December 1st. Due to DOS entries and conflicts there may be changes in the running order. Please check your confirmation & posted running order for accuracy.

Trial setup will be Friday December 2nd at noon. Anyone who comes to help is welcome to setup their crating area **AFTER** trial setup is complete.

Parking is in the large back lot on the EAST side of the building. Please do not park in the small front lot on the southeast side. You will be asked to move.

Those who need to see Mandii (Trial Secretary) please do so before 7:30 a.m. day of trial.

Exhibitors entering agility trials held at Medina Swarm must comply with all Federal, State and Local laws, and at any time is done entirely at your own risk. Per the CDC it is highly recommended, and encouraged, that those who are unvaccinated, compromised, or have vulnerable members at home wear masks within the building, and are encouraged to social distance. Medina Swarm will not be supplying masks.

Note per the CPE Premium

No changes to trial results will be made once the trial has been completed – handlers are responsible for the accuracy of information in their confirmation from the trial secretary (dog’s info, level, height category and/or jump height, etc), prior to running in a trial, and for reporting any discrepancies of posted results prior to leaving the trial site each day. This also includes if there was a correction to a scribe sheet – the handler must verify that the results were corrected as well.
